As per the reference cited above once again it is reiterated that the Sexual Harassment of Women at work place (Prevention, Prohibition & Redressal) Act 2013, every institution is mandated to constitute an internal committee to receive complaints and take action on sexual harassment of women in work place.

As per the provisions of the said act, the Internal Committee must have a senior level women Teacher or Employee as Presiding Officer. Besides, a minimum of two Teachers from the College or School having experience in social work and legal knowledge. The committee should also include a member from NGO or Association committed to women's cause.

The Heads of the Institutions are requested to constitute the committee as required immediately and report the same to this office. Besides, the names of the members and its constitution must be displayed prominently in the notice board of the institution.

The Teachers & Staff must be apprised of the scope of the provision of any compliant of sexual harassment in the work place and its redressal by the committee.
